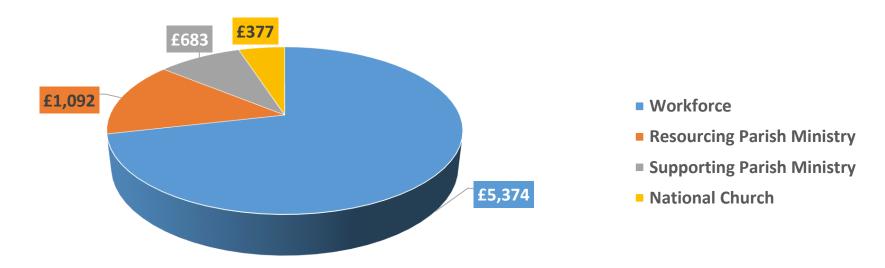

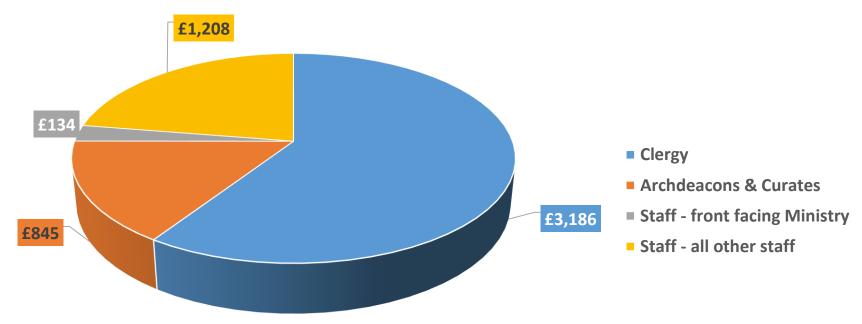
## In 2024 forecast costs could be £7,526k (Budget 2023: £7,434k)



- Workforce costs include +2% pay award from April 2024
- Non workforce costs based on 2023 forecast outturn at P5 plus 2% inflation



## In 2024 workforce costs could be £5,374k (Budget 2023: £5,283k)

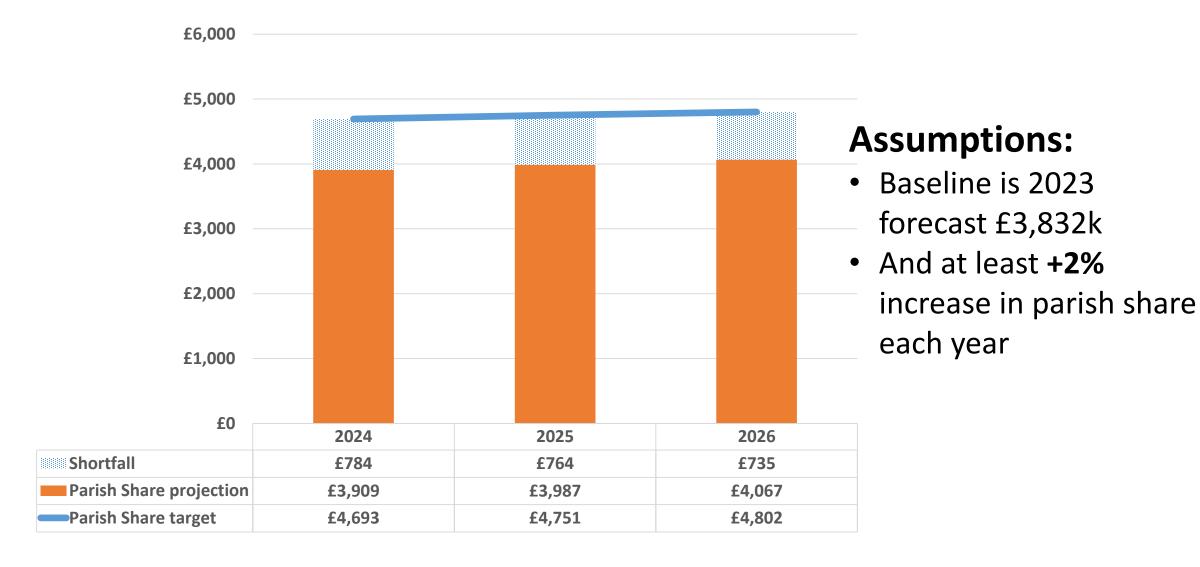
### What would be the Parish Share target for 2024 – 2026? (figures in £k)



- Other income is 2023 forecast at P5 plus 2%
- Other income also adjusted for National Church funding changes
- Annual cost inflation 2%

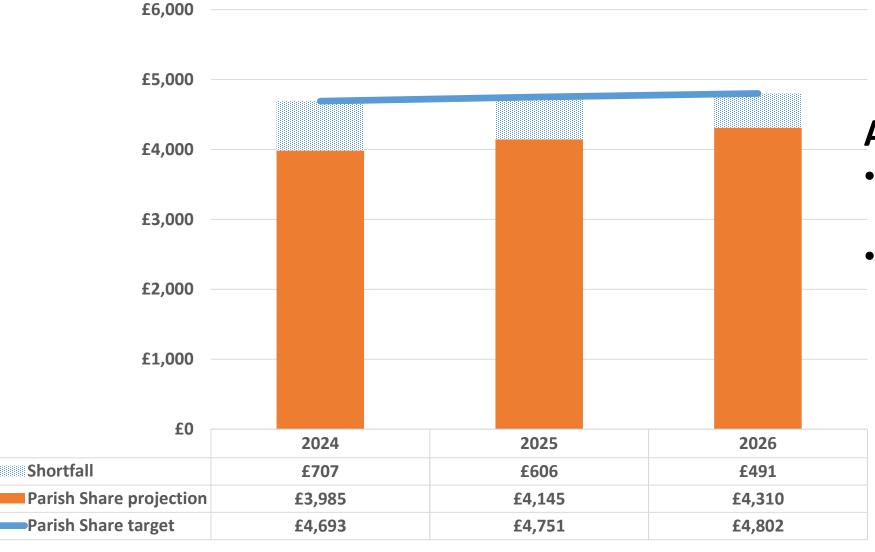


### What if Parish Share increased by 2% each year? (figures in £k)





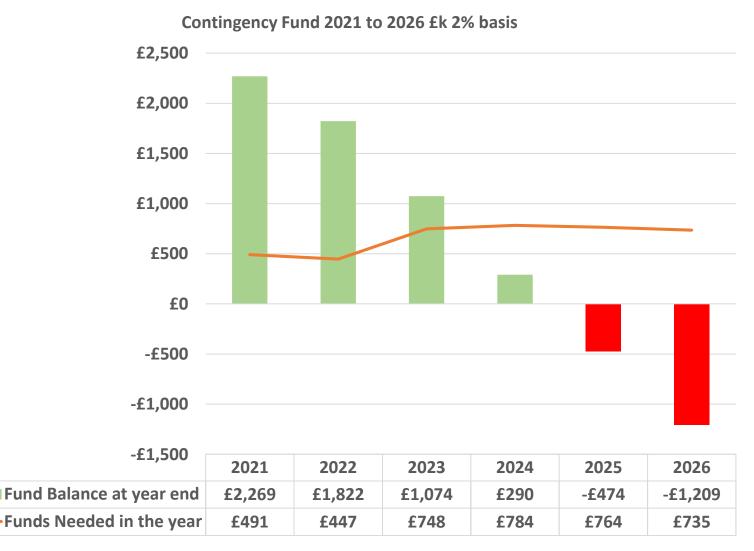
### What if Parish Share increased by 4% each year? (figures in £k)

   increase in parish share each year

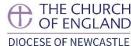


### How can the Diocesan Contingency Fund help with 2% Share increase? (figures in £k)

- Sufficient to cover £290k of shortfall into 2025
- Runs out during 2025
